Hamilton Alanson Know all men by these presents that Hamilton of Brookfield in the County of Worcester and Commonwealth of Massachusetts, to Gonah Barnes, yeoman, in consideration of eight hundred and thirty dollars paid by Gonah Barnes and Noah Barnes both of North Brookfield in said County of Worcester, yeomen, the receipt whereof I do hereby acknowledge do hereby give grant sell and convey unto the said Gonah Barnes & Noah Barnes their heirs and assigns the following described tracts and parcels of land one of said tracts lying in said North Brookfield and bounded as follows viz beginning at a corner of said land on the road leading past the house of John Tyler & at a corner of land owned by Kitridge Hill then N. 12° E. by said Hills land Seventy three rods and fifteen links thence N. 17° 40' S. by land of Joseph Dane sixty rods & eight links to land of David Gilbert thence N. 9° 20' E. by land of said Gilbert and land belonging to the heirs of Daniel Allen fifty six rods and four links to land of Anna Spooner thence easterly by land of said Spooner and land of Leonard & George Chase until it comes to land of John Tyler thence southerly by said Tylers
