Allen, their heirs and assigns, a certain tract or parcel of land together with all the buildings thereon standing, situate in said Mendon on the westerly side of the friend burying ^{ground} in the North parish, containing by estimation, one hundred and fifty rods be the same more or less, bounded as follows, viz Easterly on the said friends burying ground; southerly on a town road, and northerly on the road formerly the turnpike leading from Boston to Hartford, and lays in the form of a wedge in the fork of said roads, with all the privileges and appurtenances thereunto belonging — To have and to hold the afore granted premises to the said Amariah Taft and Caleb V. Allen, their heirs and assigns, to their use and behoof forever. And I do for myself, my heirs, executors and administrators, covenant with the said Taft and Allen their heirs and assigns, that I am lawfully seized in fee of the afore granted premises; that they are free of all incumbrances, except a mortgage to Amariah Taft of eight hundred dollars and interest; that I have good right to sell and convey the same to the said Taft and Allen, and that I will warrant and defend the same premises to the said Taft and Allen, their heirs and assigns forever, against the lawful claims and demands of all persons — In witness whereof I the said Lewis Boydew
