Penniman Abby Remow all men by these presents that I Abby Penniman of Mendon in the County
to Worcester and Commonwealth of Massachusetts Singlewoman in consideration of
Dealmann G. Wood four hundred and ten dollars paid by Dealmann G. Wood of the same Mendon Town
the receipt whereof I do hereby acknowledge do hereby give grant sell and convey unto
the said Dealmann G. Wood his heirs and assigns one undivided fifth part and two
sevenths of one fifth part of two certain tracts of land situated in said Mendon with
the buildings thereon. The first tract contains about two acres be it the same more
or less on which the house is situated bounded beginning at a corner of wall at the
southerly corner of the piece it being on the Westerly side of the road leading from the
old meeting house by Moses T. Chaffins then North 29 $\frac{1}{3}$ ° West 22 rods 16 links then
North 68 $^{\circ}$ East 16 rods to said road then two lines bound by Thomas Gardner's land
then southerly and bounding by said road to the place of beginning. — The second
piece contains fifty eight acres be it the same more or less bounded as follows to wit, be-
ginning at a corner of wall on the Easterly side of the aforesaid road nearly opposite
said house then North 84 $\frac{2}{3}$ ° East 22 rods 10 links then North 73 $\frac{2}{3}$ ° East 11 rods 10 links
then South 35 $\frac{1}{2}$ ° East 3 rods 22 links to a stake and stones then North 33 $^{\circ}$ East 31.

and stones at said road then Northerly and bounding Westerly by said road to the
place of beginning, bounding Northerly partly by Thomas Gardner and partly by Adam
Whaleck's land Easterly by Samuel Gaskill's Nahum Gaskill's Asa Gilson's Widow
Hinrich Cooks and Widow Caleb Haywards and Southerly by Albert Gardner's land
or however the same is reputed to be bounded or described. The other undivided
parts of said premises have recently been conveyed to said Dealmann G. Wood by Alan-

good right to sell and convey the same to the said Dealmann G. Wood and that
I will warrant and defend the same premises to the said Dealmann G. Wood his
heirs and assigns forever against the lawful claims and demands of all persons.
