set off to Harriet Thurber, widow of Daniel Thurber, late of Mendon, deceased,
as her dower in the estate of said deceased; for a particular description of said
premises, reference may be had to the return of the Commissioners appointed to
set off said dower, as recorded in the Probate Office, of said County of Worcester.
The estate hereby conveyed is the right of reversion to one fifth part of said
dower, held by said Chloe as her property at her decease.
