In witness whereof, I the said Lewis F. Gardner and Hannah S. Gardner, wife of the said Lewis F. Gardner in token of her voluntary relinquishment of her right of dower in said premises have hereunto set our hands and seals this second day of October in the year of our Lord one thousand eight hundred and forty eight.

Holbrook, wife of the said Leander Holbrook in her own right; all of Milford in the County of Worcester and Commonwealth of Massachusetts, and Joseph Webb of Sutton in the County of Worcester and Commonwealth aforesaid and Ruby Webb, wife of the said Joseph Webb in her own right, in consideration of two hundred and twenty dollars paid us by Amasa Parkhurst of Milford in the County and Commonwealth aforesaid. Yeoman, the receipt whereof we do hereby acknowledge, do hereby grant, sell, and quit-claim unto the said Amasa Parkhurst his heirs and assigns, all our right, title, claim, and demand, in and unto a certain tract or parcel of land situate in said Milford on the North side of the County road leading from said Milford to Holliston, bounded and described as follows, to wit: Beginning at a stone post on the said County road at the Southwesterly corner of the premises and land of the grantees, thence East by North on said road, seven rods, to land of Otar Tilson and a stone post, thence North by West, eleven rods, more or less, on line of said Tilson land, to stone post and land of John Erskine, thence West by South seven
