 said Gaskill County of Worcester and Commonwealth of Massachusetts  
 yeoman in consideration of fourteen hundred dollars paid  
 by Samuel Gaskill of Mendon aforesaid yeoman the receipt  
 whereof is hereby acknowledged do give grant sell and con-  
 -vey unto the said Samuel Gaskill his heirs and assigns a  
 certain tract of wood and pasture land lying in Milford  
 in said County on the Westerly side of the road leading by  
 Richard M. Metcalf bounded as follows viz. Beginning at a  
 corner of Lemuel Bewings land by Abijah Howards land  
 thence South 78 $\frac{1}{2}$ ° West about 90. x. bounding Northerly on Abijah  
 Howards land thence South 12 $\frac{1}{2}$ ° East 28 $\frac{1}{2}$  rods bounding Westerly  
 on land of Samuel Warfields land thence South 86 $\frac{1}{2}$ ° East 72.  
 rods thence North 6 $\frac{1}{2}$ ° East 11 rods & 23 links the two last lines  
 bounding Southerly on John G. Gilberts land to the road a-  
 -foreaid thence Northerly on said road till it comes to Lemuel  
 Bewings land thence Westerly then Northerly on said Bewings  
 land to the place of beginning containing twenty seven acres and  
 forty eight rods or the same more or less. To have and to hold  
 the aforesigned premises to the said Samuel Gaskill his heirs  
 and assigns to his and their use and behoof forever And I do  
 for myself my heirs executors and administrators covenant with  
 the said Samuel Gaskill his heirs and assigns that I am law-
