 signs, that the premises are free from all incumbrances made or  
 suffered by me, and that I will and my heirs, executors and  
 administrators, shall warrant and defend the same to the said  
 William P. Hood his heirs and assigns forever, against the lawful  
 claims and demands of all persons claiming by, through or un-  
 der me, but against none other.
