that I, Myra C. Allen, wife of Charles H. Allen of Mendon, in the County of Worcester and Commonwealth of Massachusetts, in my own right, in consideration of Two Hundred and Twenty-five Dollars, paid by Bertha Coleman, of said Mendon, the receipt whereof is hereby acknowledged, do hereby REMISE, RELEASE, and forever QUITCLAIM unto the said Bertha Coleman, her heirs and assigns, a certain tract of parcel of land with the buildings thereon, situated in the centre village in said MENDON, on the easterly side of Elm street, so called, and bounded and described as follows, viz: Beginning at the northwesterly corner of the granted premises, at a point on said Elm street, and at a corner of land of George M. Taft; thence S. 38½° E. on said street, three rods and sixteen links to corner of land of Eugene E. Brown; thence N. 67½° E eight rods and two links to land formerly of Charles H. Childs at stake and stones; thence N. 21½° W. on said Childs land five rods and eight links to land formerly of Anna W.
