**OUITCLAIM DEED** 

NELSON & O'COMMELL TITLE COMPANY, INC. NO. 1969

We, Rodney C. Dill and Ellen M. Dill, husband and wife as tenants by the entirety, of 6 Elm Street, Mendon, MA for consideration paid and in full consideration of Two Hundred Fifty Nine Thousand Dollars (\$259,000.00) grant to

David W. Rich and Jolena L Rich, husband and wife as tenants by the entirety, of 6 Elm Street, Mendon, MA with quitclaim covenants

The land in Mendon, Worcester County, MA, as shown on "Plan of Land located on Elm Street Mendon, Mass. owned by First Baptist Church" by Land Planning Engineering & Survey 167 Hartford Avenue Bellingham" dated June 27, 1994. Said lot shown as having a land area of 28,793 square feet, said plan recorded herewith at Book 623, Page 5, which land is situated on the easterly side of Elm Street, bound and described as follows:

BEGINNING at the southwesterly corner of the grated premises at said Elm Street at land now or formerly of one Brown;

THENCE N. 84 degrees E, 9 rods 22 links to a corner:

THENCE N. 14 1/2 degrees W by land now or formerly of one Marlow, 4 rods;

THENCE N. 61 ½ degrees E, by said last-mentioned land 5 ½ links to a corner;

THENCE N. 20 ½ degrees W, by land now or formerly of one Moores, 3 rods 16 links to a point;

THENCE N. 21 ½ degrees W partly by land now or formerly of one Creasia, and partly by land of the grantee, 5 rods 20 links to a corner;

THENCE S. 67 ¼ W, by land now or formerly of one Shattuck, 8 rods 2 links to said Elm Street;

THENCE southerly by said Elm Street, 2 rods 11 links to a point;

THENCE continuing by said Street, 6 rods 24 links to the place of beginning.

Excepting from the above-described parcel that portion thereof conveyed by James A.E. Brown to Herbert E Whiting by deed dated May 14, 1916 and recorded with Worcester District Deeds.
