Worcester & Commonwealth of Massachusetts (whom the receipt whereof I do hereby
acknowledge and myself thereof fully satisfied contented and paid and thereof & of
every part and parcel thereof do exonerate acquit & discharge him toward Miller his heirs
Executors and Administrators forever by these presents have given granted bargained
sold released conveyed conveyed and confirmed and by these presents do freely fully and
absolutely give grant bargain sell alien convey & confirm unto him the
said Miller his heirs and assigns forever all the land together with the buildings
and appurtenances therunto belonging devised by the last will & Testament of Colonel
Philip Ammidon late of Mendon to Sylvia Ammidon his wife & conveyed released
and quitclaimed to me the said Phillip by the heirs of the said Philip Ammidon being
bounded as follows to wit southerly by the road leading by said premises, westerly by
land of Seth Hastings Esquire northerly by land of Seth Davenport now improved
by Thomas Staples westerly by land of Joseph Fox & partly by land now improved
by Solomon Johnson to the aforesaid road together with the wood land & pasture
land the said Colonel Philip Ammidon purchased of Simon Staples & John
Ballard lying on both sides the Pumpkin road at the pond hills (so called)
Also one other piece of land with a Store thereon lying on the south side of the
