 convey and forever quitclaim unto him the said Nathan Daniels, his
 heirs and assigns forever, all my right, title, interest, claim, challenge or
 demand in and to a certain tract or parcel of lands and buildings, lying
 and being in the town of Mendon, and is bounded as followeth, beginning
 at a heap of Stones at Darius Daniels Land about two rods Westerly of a
 Chestnut tree in said Darius' Land, thence Easterly and bounded Southerly
 by said Darius Daniels Land to a heap of Stones at Aaron Leggs Land,
 thence by said Leggs Land until it comes to the road leading to Solomon
 Woods, then crossing said road and bounded by said Leggs Land and Build-
 ings until it comes to Land of Stephen Johnsons to a heap of Stones being the
 Southeast corner, thence Northerly and bounded Easterly by said Johnsons
 Land to a heap of Stones at Naaman Aldrich's Land being the Northeast
 corner, thence Westerly and bounded Northerly, by said Aldrich's Land to
 Nathl Tafts Land, then by said Nathl Tafts Land to the above said road
 then crossing said road and running Westerly by said Woodlands about
 seventy three rods to a heap of Stones by said Woods wall being the North
 west corner, thence Southerly and bounded as the wall and fence now
 stands about seventy three rods and an half to the first bounds being
 the Southwest corner it being the East half as it is now divided of the
 whole tract of Land the grantee and grantor purchased of David Legg
 as by their Deed from said Legg will make fully to appear
