Know all men by these presents that I George W. Damon of Hitch-  
 bury in the County of Worcester & Commonwealth of Massachusetts  
 yeoman in consideration of twenty six Dollars paid by Silas  
 H. Goodnow & Aaron J. Peaman both of said Hitchbury yeomen  
 the receipt whereof I do hereby acknowledge do hereby give grant sell  
 and convey unto the said Goodnow & Peaman their heirs and assigns  
 the full & free right to connect with my aqueduct near Central  
 Block in the Village in said Hitchbury for the purpose of convey-  
 ing water therefrom by means of an aqueduct to the dwelling  
 house now owned & occupied by said Goodnow & Peaman situated  
 on main Street in said Village & to draw therefrom at all times  
 as much water as will flow through a hole the size of nine or eight  
 ten pins; said aqueduct of said Goodnow & Peaman to be always  
 supplied with good water to the aforesaid quantity; and if said aqu-  
 educt of said Damon or the Spring with which it connects sit-  
 uated near the house now owned & occupied by said Damon shall  
 at any time be injured or out of repair & said Damon shall neg-  
 lect to repair the same so as to affect the supply of water aforesaid  
 then said Goodnow & Peaman may enter along said aqueduct  
 & to & about said Spring & repair the same at his expense  
 I have and hold the aforesaid premises to the said Silas H.  
 Goodnow & Aaron J. Peaman their heirs and assigns to them  
 & their use and behoof forever and I do for myself my heirs  
 executors and administrators covenant with the said Goodnow  
 & Peaman their heirs and assigns that I am lawfully seized  
 in fee of the aforesaid premises that they are free of all incum-  
 brances that I have good right to sell and convey the same to the  
 said Goodnow & Peaman and that I will warrant and defend  
 unto the said Goodnow & Peaman their  
 heirs and assigns forever against the lawful claims and demands  
 of all persons
