Know all men by these presents, that we, Alpha Morris, Widow, Eliab T. Morris, & Ann Morris, wife of said Eliab, Nathan M. Morris, and Abner Morris, wife of said Nathan M., Elias S. Ballou, Jr., William Henry Gillson & Alpha W. H. Gillson, wife of said William Henry, all of Cumberland, in the State of Rhode-Island, in consideration of Two hundred and eighty and five dollars, paid by Annette L. Weatherhead, of Mendon in the County of Worcester, and Commonwealth of Massachusetts, wife of Abel Weatherhead, of said Mendon, the receipt whereof is hereby acknowledged, do hereby remise, release and forever quit-claim, unto the said Annette L. Weatherhead, her heirs and assigns, a certain tract of land with all the buildings thereon, situated in said Mendon, on the north-
 westerly side of the road leading from the Store of Henry W. Aldrich, to Highbridge, & bounded as follows: Beginning at a point on said road, at the southeasterly corner of said tract, at land of Henry W. Aldrich, thence northerly and bounded easterly on land of said Aldrich and land - Abbie E. F. Danforth, as the wall now stands, to a corner of wall, at land of William H. Aldrich, thence turning & running westerly and bound northerly, on land of said William H. Aldrich, as the wall now stands, to a corner of fence and wall, thence turning & running southerly, and bounded westerly, on land belonging to the heirs of Charles L. Hastings, to the road, afore-mentioned, thence turning & running easterly and bounded southerly, by said road, to the bound first mentioned, at the place of beginning. For a more particular description, reference is made, to a deed from Marcia M. Stone to Abdaide M. Stone, recorded in the Registry of Deeds, at Worcester, Book 484, Page 641. To have and to hold the above-released premises, with all the privileges and appurtenances to the same belonging, to the said Annette L. Weatherhead, her heirs and assigns, to her and their use and behoof forever. And we the said Alpha, Eliab T., Ann, Nathan M., Abner, Elias S., William Henry & Alpha W. H., for ourselves, and our heirs, executors and administrators, do covenant with the said Annette L. Weatherhead, her heirs and assigns, that the premises are free from all incumbrances, made or suffered by us; and that we will and our heirs, executors and administrators, shall warrant and defend the same to the said Annette L.
