

Northeasterly on the forementioned road; thence South 65° West 10 rods to a turn in the fence; thence South $52\frac{1}{2}^{\circ}$ West 4 rods to a turn; thence South 35° West 12 rods to a turn; thence South 32° West 4 rods and 17 links; thence South $51\frac{1}{2}^{\circ}$ West 4 rods; thence South 61° West 14 rods and 7 links to a brook; thence South 83° West 26 rods to a corner of wall; thence North 82° West 18 rods to a turn; thence North 69° West 14 rods crossing said Gomuck old road to the West side of it; the said nine lines last mentioned bounding on land belonging to the estate of Nathan C. Aldrich aforesaid; thence South $31\frac{1}{2}^{\circ}$ West 16 rods to a turn in the road; thence South 57° West 40 rods to a turn; thence South 75° West 13 rods and 15 links to the corner of Lewis B. Gaskill's land; the three last mentioned lines bounded Easterly on said road; thence N. 37° West 12 rods and 11 links; thence North $20\frac{1}{2}^{\circ}$ West 5 rods and 5 links to the end of a wall; thence North $59\frac{1}{2}^{\circ}$ West 14 rods and 15 links to end of wall; thence North 78° West 7 rods and 15 links; thence North 81° West 5 rods and 22 links; thence North 8° West 4 rods and 15 links to end of wall; thence North $5\frac{1}{2}^{\circ}$ East 7 rods; thence North $9\frac{1}{2}^{\circ}$ West 9 rods and 22 links to a corner of fence; thence South $84\frac{1}{2}^{\circ}$ West 23 rods; thence South $82\frac{1}{2}^{\circ}$ West 9 rods to end of wall; these nine lines last mentioned bounded on Lewis B. Gaskill's land; thence North 86° West 5 rods and 17 links; thence South 77° West 3 rods and 7 links to a stake and stones at Newell N. Taft's land; thence North $7\frac{1}{4}^{\circ}$ West 36 rods to a stake and stones; thence North $32\frac{2}{3}^{\circ}$ West 28 rods to a stake & stones; thence South 45° West $8\frac{8}{10}$ rods; thence South 65° West 6 rods and 23 links; thence West 8 rods to a stake and stones at land of Andrew W. Gudson; (formerly Adolphus Daniels' land); the five last mentioned lines bounding on land of Newell N. Taft; thence North $33\frac{1}{2}^{\circ}$ West 15 rods and 2 links to a stake; thence North $25\frac{1}{4}^{\circ}$ West 9 rods and 15 links to stones at Andrew W. Gudson's land and Thomas Gardner's corner; the two last lines bounding on said Andrew W. Gudson's land; thence North $60\frac{1}{2}^{\circ}$ East 11 rods and 10 links; thence North $65\frac{1}{2}^{\circ}$ East 7 rods and 4 links; thence North $70\frac{1}{4}^{\circ}$ East 5 rods to a stake and stones at land belonging to the heirs of Caleb Hayward deceased; the three last mentioned lines bounding on land of Thomas Gardner; thence North 67° East 80 rods to stones on a large stump, bounding Northerly on land of the heirs of Caleb Hayward aforesaid; thence South $12^{\circ}36'$ East 50 rods and 15 links to a heap of stones; thence North $71\frac{3}{4}^{\circ}$ East 5 rods and 13 links to end of wall at Ariel Cook's land; the two last lines bounding on land of grantee; thence South 16° East 10 rods and 6 links to stones on a walnut stump; thence North 83° East 83 rods
