Beginning at the northwesterly corner of the granted premises on the northeasterly side of said Hollis Street at an iron pin in the curbing and at land of one Larkin, formerly of one Ward; thence S. 57° E. twenty-nine and 18/100 (29.18) feet on said Hollis Street to a mark on the curbing at land of Luigi Tassone et ux.; thence N. 34° 57' E. thirty-three and 50/100 (33.50) feet to a spike in the ground; thence N. 23° 38' E. thirty-four and 02/100 (34.02) feet to a stake; thence N. 33° 39' E. seventy-nine and 10/100 (79.10) feet to a stake at a board fence and land of one Baker, the last three (3) courses bounding on other land of said Tassone; thence N. 56° 09' W. thirteen and 70/100 (13.70) feet to a stone bound at land of one Boyle; thence S. 37° 49' W. one hundred forty-six and 97/100 (146.97) feet by land of said Boyle, Munger and said Larkin to the point of beginning.

Meaning and intending to convey and hereby conveying the same and all the same premises as were conveyed to us by deed of Luigi Tassone et ux. dated April 1, 1943 to be recorded herewith.
