## QUITCLAIM DEED

ALBERT N. CHAMBERLAND, MARY M. CHAMBERLAND and CARL R. CHAMBERLAND, all of 29 Hastings Street, Mendon, Worcester County, Massachusetts, as JOINT TENANTS and not as tenants in common, with QUITCLAIM COVENANTS:

The land with the buildings thereon situated in Mendon, Worcester County, Massachusetts, situated on the northerly side of Maple Street, formerly called the Boston and Hartford Turnpike, and bounded and described as follows:
