

**C** O all People to whom these Presents shall come, Greeting.

Know Ye, That We Edmund Potter of Sutton in the County of Worcester & Province of the Massachusetts Bay in New England from an Sarah Potter Wife of the s<sup>r</sup> Edmund Potter

For and in Consideration of the Sum of One hundred thirty three Pounds thirteen shillings eight pence to us in Hand before the Ensealing hereof, well and truly paid by Lebulan Goffe of Mendon in the County & Province aforesaid Husbandman — the Receipt whereof We do hereby acknowledge, and ourselfes therewith fully satisfied and contented; and thereof, and of every Part and Parcel thereof, do exonerate, acquit and discharge him the said Lebulan Goffe and his Heirs, Executors and Administrators, forever by these Presents: HAVE given, granted, bargained, sold, aliened, conveyed and confirmed; and by these Presents, Do freely, fully and absolutely give, grant,

his Heirs and Assigns forever, a certain Tract or Parcel of Land situate lying & being in the Townships of Mendon, & Aylton containing about Ninety Acres be the same more or less & is bounded as followeth beginning at a Stake & heap of Stones being the South East corner & is bounded Southwardly on a Road about thirty three rods to Edward Rawson Esq<sup>r</sup> North corner then bounded Southwardly one hundred and eighteen Rods to a bay tree lands to his Northwest corner then turning Northwardly I bounded Westwardly on James Rights land & part of George Bruce Jun<sup>r</sup> land to the Northwest corner to a heap of Stones then turning Southerly Eastwardly bound Northwardly on S<sup>r</sup> Bruce's land to a Stake & heap of Stones being the Northwest corner then turning & running Southerly by the various line and is bounded Eastwardly & Northwardly on Land of Edward Rawson until it comes to his Southwest corner then is bounded Eastwardly on a Road formerly land Out to the Stake & heap of Stones first mentioned for a South East corner their being a Road laid through the Northwest Part of said land not paved away or however otherwise bounded or Reputed to be Bounded by the Proprietors Record in Mendon —

To have and to Hold the said granted and bargained Premises, with all the Appurtenances, Privileges and Commodities to the same belonging, or in any wise appertaining, to him

the said Lebulan Goffe & to his Heirs and Assigns forever. To his and their only proper Use, Benefit and Behoof forever. And We the said Edmund Potter & Sarah Potter for ourselfs Heirs, Executors and Administrators, do Covenant, Promise and Grant to and with

him the said Lebulan Goffe & with his Heirs and Assigns, that before the Ensealing hereof, We are the true, sole and lawful Owner of the above-bargained Premises, and are lawfully seized and possessed of the same in our own proper Right, as a good, perfect and absolute Estate of Inheritance in Fee Simple: And have in ourselves good Right, full Power and lawful Authority, to grant, bargain, sell, convey and confirm said bargained Premises in Manner as aforesaid: And that he the said Lebulan Goffe & his

Heirs and Assigns, shall and may from Time to Time, and at all Times forever hereafter, by Force and Virtue of these Presents, lawfully, peaceably and quietly Have, Hold, Use, Occupy, Possess and Enjoy the said demised and bargained Premises, with the Appurtenances, free and clear, and freely and clearly acquitted, exonerated and discharged of, from all and all Manner of former or other Gifts, Grants, Bargains, Sales, Leases, Mortgages, Wills, Entails, Jointures, Dowries, Judgments, Executions, or Incumbrances of what Name or Nature soever, that might in any Measure or Degree obstruct or make Void this present Deed.

Furthermore, We the said Edmund Potter & Sarah Potter

Executors and Administrators, do Covenant and Engage the above-demised Premises to him the said Lebulan Goffe & to his Heirs and Assigns,

against the lawful Claims or Demands of any Person or Persons whatsoever, forever hereafter to Warrant, Secure and Defend by these Presents.
