premises during my natural life —

heirs and assigns to him and their use and behoof forever And I do covenant
with the said Enos Goff his heirs and assigns that I am lawfully seized
in fee of the premises that they are free of all incumbrances and that
I will warrant and defend the same to the said Enos Goff his heirs and
assigns forever against the lawful claims and demands of all persons

the said Zebulon in token of ratifying and confirming of their rights of Power
have hereunto set our hands and seals this eighth day of April A.D. 1806

Know all men by these presents that I Joseph Adams
of Mendon in the County of Worcester & Commonwealth of Massachu-
setts Phys^{ic} in consideration of one hundred and fifty dollars paid to me by
Enos Goff of the same Mendon the receipt whereof I do hereby acknowl-
edge do hereby give grant sell and convey unto the said Enos Goff
his heirs and assigns a certain tract of land lying in the Town of Mendon
aforesaid being part of the long Swamp (so called) containing by
estimation there are therein more or less bounded as follows
(viz) Beginning at a stake and stones in a ditch at the south west cor-
ner of land belonging to Seth Davenport Jr thence running northerly
about 26 rods to the south east corner of Zebulon Goff's land bound-
ing easterly on said Davenport's land thence running & running west-
erly by said Zebulon Goff's land about 13 rods to Stephen Woodland
thence southerly by said Woodland as the well now stands about 27
rods to a stake and stones thence easterly about 13 rods to the first
mentioned bound bounding southerly on the grantor's land —

To have and to hold the same to the said Enos Goff his heirs & assigns
to him and their use and behoof forever And I do covenant with the said Enos
Goff his heirs and assigns that I am lawfully seized in fee of the premises
that they are free of all incumbrances and that I will warrant & defend the
same to the said Enos Goff his heirs and assigns forever against the lawful
claims & demands of all persons — In testimony whereof we the said Joseph
