Know all men by these presents that I George Staples of Mendon in the County of Worcester yeoman in consideration of the love good will favour and affection I bear to my well beloved son Benoni Staples husbandman the receipt whereof I do hereby acknowledge have remised released and forever quit claimed and do by these presents remise release and forever quit claim unto the said Benoni Staples his heirs and assigns forever a certain parcel or tract of land out of my homestead farm lying in said Mendon containing by estimation $\frac{3}{4}$ of an acre be the same now or hereafter better and bounded as follows to wit beginning at a heap of stones on Easterly side of a road leading from and by the grantors dwelling house by Simeon Wheelocks dwelling house and about five rods Northerly of the grantors hog pen thence Easterly about rods to a heap of stones thence Northerly two rods to heap of stones thence Easterly seven rods to a heap of stones by well on the southerly side of a road leading into the first mentioned road all the above described lines bounding southerly and Easterly on the grantors other land thence Westerly and bounding Northerly last mentioned road until it comes to the first mentioned road thence Southerly and bounding Westerly on first mentioned road to the first mentioned bound — To have and to hold the same together with all the privileges and appurtenances therunto belonging to him the said Benoni Staples his heirs and assigns forever —
