Know all men by these presents that I Baxter Wood of Boylston in the County of Worcester & Commonwealth of Massachusetts a man in consideration of four hundred & fifty dollars paid by Jonathan Stratton of said town County & Commonwealth the receipt whereof I do hereby acknowledge do hereby give grant sell & convey unto the said Jonathan Stratton his heirs & assigns two several lots of land lying & being in the Northeast part of said Boylston one lot with the buildings thereon contains thirteen acres & a half the same more or less bounded as followeth viz^z beginning at the Northeast angle at a heap of stones by the side of the County road & bounds Southwesterly on said road twenty eight rods then turning & still bounding on said road twenty eight rods to a heap of stones thence East 25 1/2° South twenty one rods to a heap of stones thence East 24° South thirty one rods to a oak stand thence East 15° North eighteen rods to white oak tree thence North 9° West forty five rods to a pine thence West 11° North fourteen rods to white oak tree thence to the first mentioned bound four & a half rods - The other lot contains thirteen acres the same more or less & is bounded as follows beginning at heap of stones by the same County road & runs North 23 1/2° East twenty seven & a half rods to a heap of stones thence West 27° North forty & a half rods to a pine tree thence West 41° North twenty rods to a heap of stones thence South 42 1/2° West twenty five rods to a pine tree thence East 18 1/2° South twenty one rods to a heap of stones thence South 15° East thirty nine rods to a heap of stones by said road thence by said road to the bound first mentioned -

I have & do hold the aforegranted premises to the said Jonathan Stratton his heirs & assigns to his & their use & behoof forever. And I do for my self my heirs & executors & administrators covenant with the said Jonathan Stratton his heirs & assigns that I am lawfully seized in fee of the aforegranted premises that they are free of all incumbrances that I have good right to sell & convey the same to the said Jonathan Stratton & that I will warrant & defend the same premises to the said Jonathan Stratton his heirs & assigns forever against the lawful claims & demands of all persons - In witness whereof I the said Baxter Wood & Sally my wife in token of relinquishing her right of dower in the aforegranted premises have hereunto set our hands & seals this second day of August in the year of our Lord one thousand eight hundred & twenty three -
