Beginning at the northeasterly corner of the granted premises at a stake at the corner of said Maple Street and land of one Daige; thence southerly 4° 30' E. 200 feet along said Daige land to stake and stones at land formerly of Alice G. Whiting and now of said Edward Kopeski et ux; thence N. 89° 5/100ths' W. 65 feet along said Kopeski land to a stake at said Kopeski land; thence N. 4° 30' W. 200 feet along said Whiting's land to a stake at said Maple Street; thence S. 89° 5/100ths' E. 65 feet along said Maple Street to the point of beginning.

Said granted premises being all the same premises conveyed by Martin P. Clark et ux to us by deed dated December 1, 1942, and recorded in Worcester District Registry of Deeds, Book 2874, Page 247.

Also another parcel of land situated in the rear of and adjacent to the above described first parcel, and being all the same premises conveyed by Sadie B. Whiting to Edward Joseph Kopeski and Rita Marie Kopeski by deed dated June 21, 1947, and recorded in said Registry, Book 3064, page 326, and bounded and described in said deed as follows:-

"Commencing at the Northwesterly corner of the granted premises in the range of land of the grantor and other land of the grantee; thence south 89° 05' East sixty-five (65) feet more or less in the range of land of the grantee to a stake at land now or formerly of Norry Daige, Et Ux; thence South 4° 30' East one hundred six and five-tenths (106.5) feet along said Daige land to a stone wall at land now or formerly of Lyman E. Wheeler; thence South 80° West sixty-five (65) feet along said Wheeler land to a stake at land of the grantor; thence Northerly by land of the said grantor one hundred six and five-tenths (106.5) feet, more or less to the point of beginning."
