I give unto my beloved Son Daniel Gops, the sum of One hundred Dollars.

I give unto my beloved Son Gebelton Gops, the sum of One hundred Dollars.

I give unto my beloved Son Elias Gops, the sum of Five Dollars.

I give unto my beloved Son William Gops, the sum of One hundred Dollars.

I give unto my beloved Daughter Eunice French the sum of One hundred Dollars.

I give unto my beloved Daughter Priscilla Sadler the sum of One hundred Dollars.

I give unto my beloved Daughter Hannah Davis the sum of One hundred Dollars.

I give unto the Heirs of my late beloved Daughter Polly 115 Wether deceased, the sum of One hundred Dollars, to be equally divided among them. Each of the above sums to be paid by my said Executor to the above named Legatees at the expiration of one year after my decease.

Lastly - If my beloved Wife should not need all the rents and profits of my Real Estate for her support the residue is to belong to my said Executor.
