Paine, thence Southerly and Easterly by said Paine land to land of Samuel Warren, thence in a Southerly by land of said Warren and the West bank of the natural channel of Mill Brook to land now or late of D. Brigham, thence Northerly and Westerly by said Brigham's land to said Havenland, thence Easterly and Northerly by said Haven land to the place of beginning containing by estimation nine & one half acres be the same more or less, meaning and intending hereby to convey all that estate conveyed to me by William Knight & wife by deed of even date herewith.

To have and to hold the aforesigned premises to the said Edwin Conant his heirs and assigns to his & their use and behoif forever. And I do for myself my heirs executors and administrators covenant with the said Edwin Conant his heirs and assigns that I am lawfully seized in fee of the aforesigned premises, that they are free of all incumbrances, that I have good right to sell and convey the same to the said Edwin Conant and that I will warrant and defend the same premises to the said Edwin Conant his heirs and assigns forever against the lawful claims and demands of all persons.

Provided nevertheless that if the said Gideon Dennis his heirs executors or administrators pay to the said Edwin Conant his heirs executors administrators or assigns, the sum of six hundred and twenty dollars as follows. one hundred and twenty dollars in one year from date, and one hundred dollars in two years from date and four hundred dollars in three years from date with interest on the whole semiannually then this deed as also a certain note bearing date with these presents given by the said Gideon Dennis to the said Edwin Conant to pay the same sum at the time aforesaid shall be void. otherwise shall remain in full force.
