

then the mortgagor may, at its option, either,

(a) enter upon the premises and complete the same and add to the mortgage balance then due all sums advanced and reasonable costs incurred and the mortgagor agrees to pay as part of the principal obligation under its mortgage all sums so added, or

(b) declare the entire mortgage balance immediately due and payable and take any legal steps or foreclosure proceedings it deems necessary to enforce its rights under this mortgage and the note secured thereby.

This mortgage is upon the statutory condition and also upon the further conditions set forth in a certificate of standard mortgage conditions of said Worcester Federal Savings and Loan Association duly recorded in the Registry of Deeds or filed with the Land Registration Records where this mortgage is to be recorded or filed, which standard mortgage conditions are expressly incorporated herein by reference, and upon any other conditions herein set forth, for any breach of any of which the mortgagor shall have the statutory power of sale.
