 rods 10 links to the afore-said Worcester & Providence road, the six last lines
 bound Northerly & Easterly on Seth Davenport's land, then $S 15^{\circ} E 21$ rods,
 then $S 17\frac{3}{4}^{\circ} E 68$ rods, then $S 24\frac{2}{3}^{\circ} E 15$ rods to the first mentioned bound the
 three last lines bound Easterly on the last mentioned road, Reserving the
 School-house & the land on which said house stands, and reserving also

 Also one piece of wood-land situated on the Northerly side of the

 erly corner of the piece at West River, so called, it being at the Southerly cor-
