

The piece it being at a corner of Elisha Woods land thence N 27° E 93° rods to heap of stones on a ledge of Benoni Howards land bounding Easterly on said Elisha Woods land thence N $28\frac{1}{4}^{\circ}$ E 51° rods 12 links to Nathan Georges land bounding Easterly on said Howards land then N $66\frac{1}{4}^{\circ}$ W 78° rods 10 links to land belonging to the heirs of Levi Rawson deceased bounding Northerly on said Georges land then S 27° E 90° point 82 rods to heap of stones at the last mentioned road bounding West on said heirs land thence Easterly & bounding Northerly on said road about forty one rods to the first mentioned bounds. — — — — — Also one other piece of meadow and plain land situated in the Easterly part of Northbridge in the said County and Commonwealth aforesaid containing by estimation twenty five acres to the same more or less bounded as follows to wit beginning at the Westerly corner of the piece at West river (so called) it being at the Southerly corner of land formerly owned by Levi Rawson (now deceased) thence Southwesterly & bounding Westerly on said river to Ezekiel Wood Jr. land then Easterly by a ditch to heap of stones on a rock then Easterly & bounding Southerly by said Woods land to a stump with stones to land of Nathaniel Rist deceased then Northwesterly & bounding Easterly partly on said Rists & partly on said Woods land to a heap of stones at Adrich Streeters land then Westerly & bounding Northwesterly on said Streeters land to heap of stones at the said Levi Rawson deceased land then Westerly & bounding Northwesterly on said Rawsons land to the first mentioned bounds with all the privileges and appurtenances therunto belonging. — — — — — To have and to hold the aforesigned premises to the said Otis Thayer his heirs and assigns to his & their use and behoof forever and I do for myself my heirs executors and administrators covenant with the said Otis Thayer his heirs and assigns that I am lawfully seized in fee of the aforesigned premises that they are free of all incumbrances that I have good right to sell and convey the same to the said Otis Thayer and that I will warrant and defend the same premises to the said Otis Thayer his heirs and assigns forever against the lawful claims and demands of all persons. — — — — —
