both of North Brookfield in the County of Worcester and commonwealth of  
Massachusetts Yeomen in consideration of one hundred & thirty dollars paid  
by Joseph Dane of Brookfield in said County by command Sarah Waite of said North  
Brookfield widow the receipt whereof we do hereby acknowledge do hereby give grant  
to sell and convey unto the said Joseph Dane & Sarah Waite their heirs and  
assigns two undivided forty ninth parts of the following described real estate lying  
and being in said North Brookfield bounded as follows viz about one hundred & eig-  
ty acres of land one piece bounded Northwesterly on land of Josiah R. Southard Neigh-  
borly on land of Hervey Gilbert Southerly on land of John Tyler & Easterly on  
land of William Tyres one other piece of meadow land bounded on all sides by land  
belonging to the heirs of Gedeliah Deland it being the farm & all the real estate of  
which William Dane late of North Brookfield died seized and possessed, for a more  
particular description of said land reference is had to one deed from Thomas  
Cummings & Jonathan Sampson to said, Atm<sup>t</sup> Dane dated March 30<sup>th</sup> 1762 &  
also a Deed from Daniel Wyman to said William Dane dated May 7<sup>th</sup> 1770 —  
To have and to hold the aforesaid premises to the said Joseph Dane & Sarah  
Waite their heirs and assigns to their use and behoof forever and we do for our  
selves our heirs executors and administrators covenant with the said Joseph Dane  
& Sarah Waite their heirs and assigns that we are lawfully seized in fee of the

Cheney Dane with Sally Dane wife of said Cheney in token of the relinquish-  
ment of her right of dower & power of thirds in & to the above described premises,  
have hereunto set our hands and seals this twenty eighth day of February in
