 acknowledge do hereby give grant sell and convey unto the said
 Elias his heirs and assigns a certain tract of land lying in
 the town of Mendon County of Worcester & State of Massachusetts bound-
 ed as follows viz West by the County road leading from
 Worcester to Providence North by land owned by Gibbs Daven-
 port East by land owned by said Davenport South by
 land formerly owned by Perry Daniels & now owned by said
 Elias Wood containing by estimation eight and one third acres
 more or less.

To have and to hold the aforegranted
 premises to the said Elias Wood his heirs and assigns to his & their
 use and behoof forever And I do for myself my heirs executors and
 administrators covenant with the said Elias his heirs and assigns
 that I am lawfully seized in fee of the aforegranted premises that
 they are free of all encumbrances that I have good right to sell and
 convey the same to the said Elias and that I will warrant and
 defend the same premises to the said Elias his heirs and assigns
 forever against the lawful claims and demands of all persons.
