Beginning at the southwesterly corner of the granted premises on the easterly side of said Avenue at other land of said Coffin; thence easterly by said Coffin land, as the wall now stands, 188 feet, more or less, to the northeasterly corner of said Coffin's other land; thence northerly by land, now or formerly, of one Taft, 57 feet to a stone wall at land of one Svedine, the last line being the southerly line of said Coffin's land extended northerly; thence westerly by said Svedine land, as the wall now stands, 188 feet, more or less, to the easterly line of said North Avenue; and thence southerly by the easterly line of said Avenue 3.76 rods to the point of beginning; subject to such rights and easements as may exist of record over the granted premises.

Said premises are conveyed subject to the agreement to erect and maintain a legal fence on the entire easterly line of the granted premises as set forth in deed of Mary E. Taft to Ralph W. Coffin et al., dated August 2, 1941 and recorded with Worcester District Deeds, Book 2851. Page 394.

THIRD PARCEL:

The land in said Mendon, with the buildings thereon, located on the southerly side of Hastings Street and westerly side of Elm Street, bounded and described as follows:-

Beginning at a stone set in the ground for a bound at the intersection of said Elm Street with said Hastings Street, thence southwesterly with said Hastings Street to the center line of Willow Brook, so-called; thence southerly and down stream with the center line of said brook to land, now or formerly, of the Milford Co-operative Bank, formerly of Alderman C. Adams and Bessie L. Cheney, February 8, 1902, W. S. Amy. Engineer," and bounded and described as follows:

Peginning at a stake at the southwesterly corner of the granted premises at land, now or formerly, belonging to one Archer and land now of George Alan Whittemore; thence N. 15° 13' W. by land of said Whittemore about one hundred fifty feet to a stake at lot numbered seven (7) on said plan, now believed owned by one Harold Seastrom; thence easterly by said Seastrom's land one hundred eighty-one and one tenth (181.1) feet to a stake at the high water mark on the westerly shore of said North Pond; thence southerly by various courses by the high water mark of said pond to land of said Archer; and thence westerly by said Archer land about three hundred sixty (360) feet to the point of beginning.

Together with a right of way in common with others over the cart road as shown on said plan.
