Know all men by these presents, that I Seth Davenport of Mendon in the County of Worcester, Commonwealth of Massachusetts, yeoman, in consideration of three thousand five hundred dollars, paid by Joseph S. Davenport of the same Mendon, yeoman the receipt whereof I do hereby acknowledge, do hereby give, grant, sell & convey unto the said Joseph S. Davenport, his heirs & assigns, a certain tract or parcel of land lying & being in said Mendon, together with all the buildings standing thereon; said tract of land contains, by estimation one hundred & forty acres be the same more or less & is bounded as follows to wit, beginning at a heap of stones on the County road at the Southwest corner of the grantors land; thence running Southerly, to a heap of stones at the Northwest corner of John Fishers land bounded Westerly by said County road which leads from Providence to Worcester; thence turning & running Easterly, to a heap of stones on the East side of Mudely brook at the Northeast corner of said John Fishers land, bounded Southerly by said Fishers land; thence turning & running Southerly to a heap of stones at Benjamin Davenports land & bounded Westerly by said Fishers & Alexander Thayers land; thence turning & running Easterly to a heap of stones on the right well road so called, bounded Southerly on said Benjamin Davenports land; thence
