

Davenport's land, thence turning Westerly, bounding Northerly by said Davenport's land to land of Charles A. Davenport; thence Westerly, bounding Northerly by the said Charles A. Davenport's land to land of Henry Goss; thence Southerly by land of said Goss, to the Cranberry Meadow, ^{owned} by Charles A. Davenport, thence Southerly, bounding Westerly by said Charles A. Davenport's land to a corner at Charles Davenport's land; thence Easterly, bounding Southerly by the said Charles Davenport's land, about eighty eight rods to the point of beginning at the road, containing about twenty three acres, more or less. Subject to any rights and privileges which Rufus Coffey may have in and to the small house and garden where he now lives, under the will of Seth Davenport late of Mendon, deceased. The above described premises are known as the James Lovett place. To have and to hold the same to the said Liberty Goss, his heirs and assigns, to his and their use and behoof forever. And we do covenant to warrant and defend said granted and quit-claimed premises to the said Liberty Goss, his heirs and assigns, forever, against the lawful claims and demands of all persons claiming by or under us or either of us.

Davenport, wife of the said George Davenport, in token of relinquishment ^{her right of} dower in said estate, have hereunto set our hands and seals, this eighth day of July, in the year of our Lord, one thousand eight hundred and forty seven.

Goss Liberty, &c. Know all men by these presents, that we, Liberty Goss, in right of his wife, and to Susan Goss, wife of the said Liberty Goss, in her own right, and Charles Davenport, George Davenport, Seaman, all of Mendon, in the County of Worcester, and Commonwealth of Massachusetts, in consideration of one dollar, paid us by George Davenport of said Mendon, in said County and Commonwealth, Boot-maker, the receipt whereof we do hereby acknowledge, do hereby grant, sell, and quit-claim unto the said George Davenport, his heirs and assigns, all our right, title, claim, and demand, in and unto the following pieces of real estate, with all the privileges and appurtenances to them belonging. The first piece of real estate is situate in said Mendon, and bounded as follows, to wit Beginning at the Northeasterly corner on the Westerly side of the Providence and Worcester road; thence South 73° West, ten rods and twenty-two links to stake and stones at the Northwesterly corner; thence South 114° East, five rods and five links to a stake by the wall; thence with the centre of the wall, North $65\frac{1}{2}^{\circ}$ East $\frac{9}{16}$ rods and twenty links to an angle in the wall; thence Easterly four rods and nine links to the Westerly side of the road; thence on the Westerly side of the road four rods, and three fourths
