Charles Davenport. - maker, all of Mendon, in the County of Worcester, and Commonwealth of Massachusetts, in consideration of one dollar, paid us by Charles Davenport, of Mendon, in said County and Commonwealth, Seaman, the receipt whereof we do hereby acknowledge, do hereby grant, sell, and quit-claim unto the said Charles Davenport, of said Mendon, Seaman, + heirs and assigns, all our right, title, claims, and demands, in and unto the following described piece of land, situated in said Mendon, with all the privileges and appurtenances to the same belonging; bounded as follows, viz: Beginning on the Westerly side of the Providence and Worcester road, at a point twelve feet Northerly of the Northeasterly corner of the School house in the first School District; thence running Northerly and bounding Easterly on said road to the Southeasterly corner of George Davenport's house lot; thence turning Westerly and running four rods and nine links to an angle in the wall; thence South 65³/₈° West, six rods and twenty links; thence North 14° West, five rods and five links to stake and stones; thence North 73° East, ten rods and twenty two links to the said road; thence running Northerly, and bounding Easterly on said road to the Southeasterly corner of the James Lovell place, (so called); thence turning Westerly and running about eighty eight rods to a corner at Otis Thayer's land, and bounding Northerly by the said James Lovell place; thence turning Southerly and bounding Westerly by said Thayer's land, to a corner; thence turning and running Easterly and bounding Southerly by said Thayer's land to a corner of land set off for a burying ground; thence turning Northerly by said burying ground to a corner; thence turning Easterly, by said burying ground, and running to a corner; thence turning and running Southerly, bounding Westerly by said burying ground to a point twelve feet Northerly of Otis Thayer's line; thence
