Davenport, Harriet B. Davenport, Ann P. Davenport, Rebecca Davenport and David D. Davenport, minor children of George G. Davenport late of said Mendon, deceased, in consideration of one dollar paid to me by George Davenport of Mendon, in said County, of Worcester, Boot-makers the receipt whereof I do hereby acknowledge, do hereby grant, sell, and quit-claim unto the said George Davenport, his heirs and assigns, all my right, title, claim, and demand, in and unto a certain piece or parcel of land, situated in the Northerly part of Mendon, with all the privileges and appurtenances to the same belonging, bounded as follows to wit: Beginning at the Southwesterly corner on the Westerly side of Providence and Worcester road at a point twelve feet Northerly of the Northwesterly corner of the School House; thence running Westerly, bounding Southerly by a twelve feet passage way leading to the grave-yard fourteen rods, 22 links to stake and stones at the grave yard; thence North $17\frac{1}{4}$ ° West, bounding Westerly by said grave-yard, four rods, $6\frac{3}{4}$ links to a corner, thence South $72\frac{3}{4}$ ° West, to a corner at land of Charles Davenport; thence North 8° West, thirty one rods 9 links to a stake in the wall, bounding Westerly by land of the said Charles Davenport; thence turning and running Easterly, bounding North by land of the said Charles, and partly by land of the grantee to the Westerly side of the said Providence and Worcester road; thence turning Southwesterly, bounding Easterly
