Know all men by these presents that I Henry Wheeler of  
Burrillville in the County of Providence and State of Rhode-  
island gentleman in consideration of fourteen hundred and  
 thirty eight dollars paid by Ezekiel P. Gaskill of Ubridge in the  
 County of Worcester and Commonwealth of Massachusetts yeoman  
 the receipt whereof I do hereby acknowledge do hereby give grant sell  
 and convey unto the said Ezekiel P. Gaskill his heirs and assigns  
 one certain tract or parcel of land situated in the Westerly part  
 of the town of Mendon with all the privileges and appurtenances  
 containing fifty five acres, the same more or less, and is bound-  
 ed as follows (viz) beginning at the corner of a wall by the road  
 running by said premises, thence Westerly by the middle of a  
 wall to land of George Mowry and bounded Northerly by land of  
 Lewis Wood and the heirs of Thorington, thence Southerly  
 the middle of a wall to walnut stump a corner of the said  
 George Mowry and bounded Westerly by said Mowry, thence  
 Easterly by the middle of a wall to the corner of said Mowry  
 and bounded Southerly by the said Mowrys land, thence  
 southerly to a corner of said Mowry, thence Easterly by the  
 middle of a wall to a corner by said road and bounded  
 Southerly by land of said Mowry and the heirs of Seth Southwick  
 thence by the bounds of said road to the first mentioned  
 bound, the above described premises was purchased by the  
 grantor of his father Simeon Wheeler To have and  
 to hold the aforegranted premises to the said Ezekiel P. Gas-  
 kill his heirs and assigns to his & their use and behoof for-  
 ever, and I do for myself my heirs executors and ad-  
 ministrators covenant with the said Ezekiel P. Gaskill  
 his heirs and assigns that I am lawfully seized in fee  
 of the aforegranted premises, that they are free of all in-  
 cumbrances that I have good right to sell and convey  
 the same to the said Ezekiel P. Gaskill and that I will  
 and my heirs shall warrant and defend the same prem-  
 ises to the said Ezekiel P. Gaskill his heirs and assigns for-  
 ever against the lawfull claims and demands of all per-  
 sons and Mary M. Wheeler wife of the said Henry Wheeler  
 for the consideration aforesaid do hereby release and quit-
