The first parcel contains fifty acres more or less
with buildings thereon and is situated on the southerly side of the
road leading from Albeeville to Uxbridge, bounded northerly by said
road; east by the road leading from Albeeville to the Chestnut Hill
Meeting house, David M. Richardson land and the schoolhouse lot; south
by Austin Wood land; and west by land which belonged to Nathan G.
Daniels, deceased.

The second parcel or tract of land lies opposite the
house on the first tract on the northerly side of said Uxbridge road;
contains ten acres, more or less, bounded north by Blanchard land and
