QUITCLAIM DEED

WE, E. JANE COLEMAN, of Mendon, Massachusetts, LOIS HOLBROOK, of Greenland, New Hampshire, CHRISTINE RAWLEY, of Millbury, Massachusetts, MELINDA GAUTHIER, of Sterling, Massachusetts, LEONARD PETERSON, of Worcester, Massachusetts, and SETH S. HOLBROOK of Boston in the County of Suffolk, Commonwealth of Massachusetts in his capacity as Administrator of the Estate of Emily L. The Grantors acquired title to all three aforegoing tracts under the Estate of Emily L. Coleman, late of Mendon in said County of Worcester, Worcester Probate Case No. 90P1105-A1.
