

a Stake and Stones on the north side of the Turnpike road being the South easterly corner of said lot of land thence running South eighty two and an half degrees west fourteen rods to a Stake and Stones and bounding Southwesterly on said Turnpike road thence North seven rods and an half degrees west twelve rods to a Stake & Stones & bounding Westerly on S^r Hastings land then turning & running North eighty two and an half degrees East thirteen rods to a Stake & Stones bounding Northwesterly or northwesterly upon land belonging to the said Hastings thence turning and running South twelve and an half degrees East twelve rods to the bounds first mentioned at the Turnpike road and bounding Easterly on said Hastings land with a reservation or exception of my proportion in the said lot of land to me my heirs and assigns according to the sum I have subscribed towards building the proposed house for public worship -

To have and to hold the above described one acre and two rods of land with the right and privilege of erecting Horse Sheds on the north side of said meeting House lot and within the limits of the Game and upon no other part of said lot of land, shall any Sheds or buildings of any kind or any incumbrance whatsoever be erected or maintained and to hold the said lot of land subject to the reservation or exception made by me the said Seth Hastings for myself my heirs and assigns as before mentioned to them the said Jonathan Russell, Benjamin Dawnsport, Seth Dawnsport, Richard George, Caleb W. Torrey & all other persons who may hereafter subscribe to the written agreement before mentioned to defray the expense of building said House for public worship, and to their heirs & respective heirs & assigns according to in proportion to the several sums of money by each of the aforesaid persons respectively subscribed towards defraying the expense of building the said House for public worship - To have & to hold the said lot of land in manner as aforesaid for the sole and only use of erecting & maintaining a house for public worship & thereon forever hereafter and the said Seth Hastings my heirs and assigns are to erect and maintain a fence or wall on the east and west sides of the said meeting House lot - In witness whereof I the said Seth Hastings have herewith put my hand & affixed my seal this twentieth day of December in the year of our Lord one thousand eight hundred & nineteen -
