 edge, do give, grant, sell, and convey unto the said Ellis and George Saft
 their heirs and assigns, a certain tract of land with all the buildings
 thereon situated in said Mendon a short distance West from the
 Unitarian Meeting house, and bounded as follows, to wit, Beginning
 at a Stake by the side of the County road (formerly the Boston and
 Hartford Turnpike) at a corner of lands of Dennis Carnes and
 Peter Rockwood, thence Easterly by and with said road seven rods and
 nineteen links to a corner at land of Holland Albe, thence turning
 and running Northerly by and with said Albes land five rods and ten &
 three quarters links to land of the aforesaid Peter Rockwood, thence turn-
 ing and running Southwesterly by and with said Rockwoods land
 seven rods and two links to the first mentioned bound.
