Know all men by these presents that I, Stephen Cook of Mendon in the County of Worcester and Commonwealth of Massachusetts, in consideration of One Hundred and Twenty-five Dollars paid by Mary J. Adams of Hopdale in said County, the receipt whereof is hereby acknowledged, do hereby give, grant, bargain, sell and convey unto the said Mary J. Adams a certain tract or parcel of land with buildings thereon situated in the Center Village of Mendon in said County upon the Northernly side of the County road formerly the Boston and Hartford Turnpike, a short distance Westernly of the Unitarian Meeting House containing one eighth of an acre more or less and supposed to be bounded as follows, to wit: Beginning at a stake and stones by the side of the wall on the Northernly side of the County road aforesaid at a corner of land supposed to belong to Sarah Wallace, thence Easterly by and with said County road seven rods and nineteen links to a corner at land of one Stevens, thence Northernly with said Stevens land five rods ten <sup>3</sup>/<sub>4</sub> links to land supposed to belong to Ellen
