northeasterly side of Providence Street;

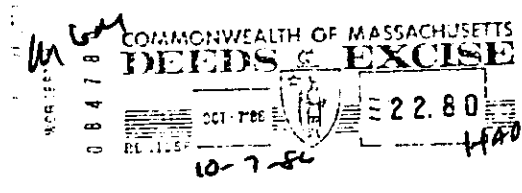
THENCE following a curve having a radius of 560 feet, the distance of 193.39
