5. I give and bequeath to Edna Enman daughter of my brother, Symon Cook, one hundred dollars.
6. I give and bequeath to Frederic Cook, son of my sister, Joanna Cook, one hundred dollars.
7. I give and bequeath to the two eldest children of my brother Adin B. Cook, one hundred dollars each.
8. I give and bequeath to Isabella C. Cook, daughter of my late brother, Ira W. Cook, five hundred dollars.
9. I give and bequeath to Alice A. and Clara S. Cook, daughter of my brother, Davis B. Cook, one hundred and fifty dollars each.
10. I give and bequeath to David C. Wilcox, my brother-in-law, the sum of fifty dollars.
11. I give and bequeath to Edward Wilcox, son of Willard Wilcox, the sum of one hundred dollars.
