

2. I give and bequeath to Deborah Daniels, wife of Cyrus C. Daniels the interest of three hundred dollars annually, during her life; and, at her decease, I give and bequeath the said sum of three hundred dollars, viz: to Susan Moore, daughter of the said Deborah one hundred dollars; to Leon son of the said Deborah fifty dollars; to Boeline Cook, daughter of the said Deborah fifty dollars and to Ella and Elida Daniels, daughters of Francis W. and Hannah Daniels fifty dollars each.

13. I give and bequeath to Willard S. Wilcox, son of Stephen Wilcox, two hundred dollars.

14. I give and bequeath to Hannah and Mary Wilcox, daughters of Stephen Wilcox, fifty dollars each.

15. I give and bequeath to the two daughters of Servander Cook, of Providence, in the State of Rhode Island, fifty dollars each.

16. I give and bequeath to Henry W. Wood Jr. son of Henry W. Wood, the sum of fifty dollars.

17. I give and bequeath to Frederick Ramon, son of Henry Ramon the sum of fifty dollars.

18. I give and bequeath to Nathan Wheelock, son of Francis E. Wheelock, fifty dollars.

19. I give and devise to Julia Wilcox, wife of Stephen Wilcox, not subject to the control of her husband, all my right, title and interest in the estate which I purchased of Angelina Daniels.

20. I give and devise to Henry Ramon, the occupancy and use of the estate which he now improves, during his life - provided, he pays all taxes which shall be assessed on the same, keeps the buildings in suitable repair, said buildings to be kept insured for three fourths their value and pay an annual rent of twenty-five dollars.

21. To my brother Stephen Cook, my brother Lyman Cook, my brother Ellis Cook, my brother Alvin B. Cook, my brother Davis B. Cook, to my sisters Lovina Stone, Goddina Cook and Fidelia Hastings I make no bequest.

22. I give and bequeath to Edward C. Cook, son of my brother Era W. Cook, all the rest and residuum of my estate both real and personal.

Lastly - I hereby nominate, constitute and appoint the said Edward C. Cook, Co-executor of this my last will and testament.

In witness whereof I, the said Aaron C. Cook have, to this my last Will and Testament, set my hand and seal this first day of March, A. D. 1873.
