5th. I give and bequeath to my daughter Mary D. Gould wife of Ellis Gould the farm situate on Willard Wilcox now lives after the decease of Hannah Wilcox wife of said Willard Wilcox excepting for my sons five acres on Mill river to be tilled on either side of said river or on both sides as my sons shall think best so long as she lives and then to go to her heirs

6th. I give and bequeath to my daughter Elmira S. Fletcher wife of Charles Fletcher the Ozias Thurber farm so called, it being the same Samuel Baskill purchased of said Thurber and if I do not build a house on said farm I also give her five hundred dollars to build a house with on said farm she is to hold the same so long as she lives and then to go to her heirs

7th. I next give and bequeath to my eight sons viz; John S. Baskill Samuel Baskill Micajah C. Baskill Gilbert Baskill Nahum Baskill Jr. Richard S. Baskill Lewis B. Baskill and Albert W. Baskill all the rest residue and remainder of my real and personal estate of what name or nature soever and where soever
