Know all men by these presents that I Adrich Anson of Mendon in the County of Worcester Commonwealth of Massachusetts yeoman in consideration of Five Thousand dollars paid by Carle W. Capron of the same Mendon yeoman thereupto when of I do hereby acknowledge & do hereby give grant well and convey unto the said Carle W. Capron his heirs and assigns a certain meadow or tract of land situated in said Mendon with the buildings thereon containing about one hundred and eighty acres being more or less bounded as follows: Beginning at the road at an oak stump thence N. $80^{\circ} 10' W.$ 10 rods 5 links; thence N. $83\frac{1}{2} W.$ 11 rods; thence W. $71^{\circ} 15' S.$ 15 rods 20 links; thence S. $55^{\circ} 11' E.$ 2 rods; thence N. $72\frac{1}{2} W.$ 15 rods; thence N. $46\frac{3}{4} W.$ 8 $\frac{1}{2}$ rods; thence N. $43\frac{1}{2} W.$ 5 rods 9 links thence N. $69\frac{1}{2} W.$ 29 rods 8 links; thence S. $11\frac{1}{2} W.$ 16 rods 18 links; thence S. $14\frac{1}{2} W.$ 5 rods to a long stone thence S. $68\frac{1}{2} W.$ 18 rods; thence S. $8\frac{1}{2} E.$ 84 rods 10 links to stones; thence S. $88\frac{1}{2} W.$ 11 rods 10 links to stones thence N. $4\frac{1}{2} E.$ 55 rods 10 links to staves and stones; thence S. $77\frac{1}{2} W.$ to land I lately sold to Volome Staples & Nahor Fletcher to a long stone; thence S. full point bounded on said staples & Fletcher's land to a corner of C.
