Daniels Rirpah

Mowry Darling.

Know all men by these presents, that I, Rirpah Daniels, of Blackstone, in the county of Worcester, and Commonwealth of Massachusetts, widow, in consideration of one thousand dollars, paid by Mowry Darling, of Mendon, in said county, Blacksmith, the receipt whereof I do hereby acknowledge, do give, grant, sell, and convey unto the said Mowry Darling, his heirs and assigns, a certain tract or parcel of land, situated in said Mendon, with a dwelling house, trip-hammer's shop and other buildings standing thereon, called the Pratt place, and is the same that was set off to Cyrus Daniels, out of the estate of his father Riley Daniels, deceased; and reference is hereby had for a more particular description of said parcel of land and buildings, to the return of the commissioners, who set off the same, recorded in the Probate Office in said county; excepting a certain piece of land, conveyed by said Cyrus Daniels to Ariel Cook, by deed dated July 5<sup>th</sup> A. D. 1842, & recorded in the Registry of Deeds office, at Worcester, Book 392, Page 275.

Mowry Darling to make and forever support the fence on the Pond side of the road, which bounds upon the land of the said Rirpah Daniels. The above tract of land, called the Pratt Place, was conveyed to the said Rirpah Daniels by Cyrus Daniels, by deed dated June twenty fifth, A. D. 1845, and recorded in the Registry of Deeds, Book 402, Page 180. The said Rirpah Daniels does not warrant and defend against any right to dower in the premises, which the wife of Solomon Pratt may hereafter have. The above includes only the Pratt Place, being the first tract or parcel set off by the commissioners to the said Cyrus D. Daniels.
