I have and to hold the aforesigned premises to the said Emory Hastings his heirs and assigns to his use and behoof forever and I do for myself my heirs, executors, and administrators covenant with the said Hastings his heirs and assigns, that I will lawfully Seized in fee of the aforesigned premises, that they are free of all incumbrances, that I have good right to sell and convey the same to the said Hastings, and that I will and my heirs shall warrant and defend the same premises to the said Hastings his heirs and assigns forever, against the lawful claims and demands of all persons. And Harriet Field wife of the said Spencer for the consideration aforesaid do hereby release and quit claim unto the said Hastings his heirs and assigns all right claim or possibility of dower in said premises.

Know all men by these presents that I Aaron C. Cook of Mendon in the County of Worcester and Commonwealth of Massachusetts, Yeoman in consideration of three hundred and Seventy five dollars paid by Ariel Cook of said Mendon in said County and Commonwealth Yeoman, the receipt whereof I do hereby acknowledge, do give, grant, sell and convey unto the said Ariel Cook his heirs and assigns a certain piece or parcel of land situated in the Southerly part of said Mendon, and bounded as follows. To wit, Beginning at the North-easterly corner on the Westerly side of the road leading from Worcester to Providence, thence South 83° West by land set off to Joanna Cook now Joanna Scott as dower 29 rods, thence North $18\frac{1}{4}^{\circ}$ West 6 rods, thence South $80\frac{1}{2}^{\circ}$ West 11 rods, thence South $83\frac{1}{2}^{\circ}$ West 21 rods
