

Daniel's Copyue 61 Know all men by these presents, that I, Cyrus L. Daniels
 of Mendon in the County of Worcester and Commonwealth of Massa-
 chusetts, in consideration of five hundred and fifty dollars paid by Leon
 Daniels and Mary Daniels wife of the said Leon jointly, the receipt where-
 of is hereby acknowledged, do hereby give, grant, bargain, sell and convey
 unto the said Leon Daniels & Mary Daniels, jointly, their heirs and as-
 signs, the following described real estate with all the buildings thereon
 lying in the Southerly part of said Mendon and bounded as follows,
 viz: Beginning at a point on the Westerly side of the Providence road five
 rods and sixteen links North of Round Meadow Brook, thence N. 57° 55'
 West nineteen (19) rods and thirteen (13) links to a drill hole in a rock,
 thence N. 63° 10' W. 35 rods & 23 links to a corner of wall by said Round Meadow
 Brook bounded Southerly by grantor's other land, thence N. 14 1/2° W. 3 rods, thence
 N. 12° E. 9 rods and 20 links, the last four courses by said Brook, thence N. 87 1/4° E.
 13 rods and 15 links, thence S. 86 1/2° E. 46 rods and 15 links by land of Gilbert
 Cook to said Providence road, thence by and with said road to the point of be-
 ginning, containing about 15 acres. Also one other piece of land nearly
 opposite the house on the lot first described on the Easterly side of said
 Providence road and described as follows viz: Beginning at the abutment
 of a wall on the South side of a barway, thence S. 65° 58' E. 5 rods & 23 links to
 a stake & stones, thence N. 27° 55' E. 8 rods to a stake and stones, thence N. 62°
 55' W. to said Providence road, thence by and with said Providence road
 to the place of beginning with all the buildings thereon containing about
 48 square rods.

To have and to hold the above
 granted premises, with all the privileges and appurtenances thereto
 belonging to the said Leon & Mary Daniels their heirs and assigns to
 them & their use and behoof forever. And I, the said Cyrus L. Daniels, for
 myself and my heirs, executors and administrators do covenant with the
 said Leon & Mary Daniels their heirs and assigns that I am lawfully
 seized in fee simple of the aforesaid premises, that they are free from
 all incumbrances, that I have good right to sell and convey the same to the
 said Leon & Mary Daniels their heirs and assigns forever as aforesaid, and
 that I will and my heirs, executors and administrators shall warrant and
 defend the same to the said Leon and Mary Daniels their heirs and as-
 signs forever, against the lawful claims and demands of all persons.
