I, Nicola Zachilli of Milford, Worcester County, Massachusetts being married, for consideration paid, grant to Secondo Lucciarini of said Milford with M O R T G A G E covenants, to secure the payment of Two Thousand Dollars on demand with 5 3/4 per centum interest per annum payable semi-annually as provided in a note of even date, a certain lot of land situated in MILFORD in the County of Worcester and Commonwealth of Massachusetts, being lot numbered sixty six (66) on plan of "Milford Driving Park" drawn by Henry W. Gaskill, C. E. dated July 1906 and filed with Worcester District Deeds, Book of Plans, . To which plan reference may be had for a more particular description. Being all the premises conveyed to me by Antonio Genroroto by deed dated May 7, 1925 and recorded with Worcester District Deeds, Book 2368, Page 475. The above lot is situate on the northerly line of the proposed Ravenna Street, so called on said plan, bounded and described as follows, to wit:- Beginning at a point in the southeasterly corner of lot No. 64 other land of the grantors; running thence northerly along the westerly line of said lot one hundred (100) feet to a stake; thence westerly parallel with said Ravenna Street, forty (40) feet, thence southerly to a stake in said street, one hundred (100) feet, thence easterly along said street, forty (40) feet to the point of beginning.
