Will.

Be it remembered that I, Sarah Whitney Wheeler, widow, of Grafton in the County of Worcester and Commonwealth of Massachusetts, being of sound and disposing mind and memory but well knowing the uncertainty of life, do hereby make, publish and declare this my last will and testament revoking any and all wills by me at any time heretofore made.

After the payment of all my just debts and funeral charges, I give, devise and bequeath as follows, viz:-

First. To my son Walter Forbush Wheeler of Ouray in the County of Ouray and State of Colorado, I give and bequeath the sum of one dollar and in addition I direct that all the notes which I hold signed by him be cancelled and delivered up to him and that he be discharged from any liability to my estate thereon.

Second. I give, devise and bequeath my real estate and household furniture and other personal property (including my shares in the capital stock of the Grafton National Bank) located in said town of Grafton, and likewise all the rest and residue of my estate whether real, personal or mixed and wherever the same may be situate, of which I shall die seized or possessed or to which I shall be entitled at the time of my decease to my daughter, Miriam Elizabeth Panin, of said Grafton, in fee simple, to have and to hold the same to her, her heirs and assigns, to her and their own use and behoof forever.

Third. I hereby constitute and appoint my said daughter Miriam Elizabeth (Wheeler) Panin to be the executrix of this my last will and testament and I direct that she be exempt from furnishing either a surety or sureties upon her official bond as executrix aforesaid.

In testimony whereof I have hereunto set my hand, and in the presence of three witnesses declared this to be my last will this twenty-fifth (25) day of May in the year of our Lord nineteen hundred and one (Anno Domini 1901).


