the receipt whereof is hereby acknowledged, do hereby remise, release, and forever quitclaim unto the said Edwin L. Wilson a certain parcel of land situated on the shore of Nipmuck Pond, so called, in said MENDON, near that portion of said pond called the "horse hole", bounded as follows: Beginning at a drill-hole in a rock at the shore of said pond, and at land of Marcus M. Aldrich; thence running with said Aldrich land, N. 70° 35' E. 106 feet to a stake at other land of the grantor; thence with said other land, S. 38° 30' E. thence still with grantor's other land, S. 70° 35' 53 feet to a stake; W. about 65 feet to the shore of the pond; thence in a varying curved line, with the shore of the pond, northwesterly to the drill-hole at the point of beginning. With such rights of way, but none other, to and from the premises over an ancient town way along or near the shore of said pond, as I am entitled to grant.
